STALLION SERVICE CONTRACT

THIS AGREEMENT made and entered into this ____ day of _____, 20__ between _____, referred to hereafter as MARE OWNER, and COLLEEN SHEILA AUFIERO, referred to hereafter as STALLION OWNER. MARE OWNER hereby contracts for stallion service for mare named _____, Breed _____, Reg. No. _____ to the stallion SHINING TOPSAIL, AQHA reg. No. 3515093 and will bring the mare to _____ on or about _____ (date), for breeding on the following terms and conditions:

1. The Stallion Service fee shall be \$1,500.00 (U.S. Funds) and shall be paid in full before the mare is released from the breeding facility. First semen shipment is included in fee; charges for additional shipments shall be paid in full by MARE OWNER.
2. A live foal is guaranteed, unless the mare leaves the breeding facility before she is pregnancy tested and pronounced in foal by a licensed veterinarian. If the mare does not settle in foal, or if the resulting foal from this breeding does not stand on its own strength and suck, MARE OWNER will be entitled to one free season. Live foal guarantee also will apply only if STALLION OWNER is notified in writing (certified mail) within one week of the death of the foal. This notice must be accompanied by a statement from a licensed veterinarian.
3. The mare shall be in a healthy sound breeding condition. Before the mare is bred, she shall be cultured by the veterinarian regularly employed by the STALLION OWNER. If she is clean and in breeding condition, STALLION OWNER shall make every reasonable effort to settle the mare. If the mare is found to be infected or otherwise not breedable condition, STALLION OWNER or the veterinarian shall so notify MARE OWNER and agree upon a course of treatment. If, after diligent effort has been expended by STALLION OWNER, the mare does not settle, MARE OWNER shall hold STALLION OWNER blameless.
4. All veterinary services are for the account of MARE OWNER and shall be billed direct by the veterinarian to MARE OWNER. However, the Stallion Service Fee will include all veterinary supplies used for sanitary breeding procedures.
5. If shod, all mares to be bred must have their hind shoes removed. This is to be done at MARE OWNER's expense, preferable before the mare arrives at the breeding facility.
6. Any farrier charges that occur shall be billed to MARE OWNER by the farrier.
7. Mares that are not halter broke will not be accepted.
8. The mare or mare and foal will be cared for in a careful and diligent manner. STALLION OWNER reserves the right to employ veterinary care at MARE OWNER's expense in case of illness or injury. MARE OWNER agrees that the STALLION OWNER shall not be held responsible for any injuries, accidents, sickness or death to either the mare and/or foal. MARE OWNER shall be notified in case of accident, injury, sickness or death.
9. MARE OWNER shall not be held responsible for any accident or injuries, which might be inflicted upon the stallion by the mare incident to teasing or breeding the mare.

10. STALLION OWNER agrees that in the event the mare originally serviced does not settle, she, or a substitute mare, approved by the STALLION OWNER, may be bred the following year. On a rebreeding of any mare, MARE OWNER shall pay the standard board, veterinary and farrier charges.
11. If, for any reason, the stallion covered by this agreement should die, become unfit for service or sold, MARE OWNER shall have the right to have any Stallion Service Fee monies already paid to the STALLION OWNER, apply toward the fee of any other breeding stallion owned and offered by the STALLION OWNER.
12. All fees, including Stallion Service, veterinary, board, farrier, shall be paid in full by the MARE OWNER before the mare is released from the breeding facility, even in the event this agreement becomes null and void for any reason.
13. Breeding season begins on February 15, and ends on July 15.
14. A copy of the mare's registration certificate shall be provided to STALLION OWNER.
15. This agreement may not be transferred or sold and shall be binding upon the parties thereto, their heirs, executors, administrators or assigns.
16. The STALLION OWNER reserves the right to use the names and photographs of stallion's foals for advertising purposes.
17. All charges accrued due to shipped semen shall be paid upon receipt.
18. Breeder's certificate will be issued when all monies have been paid in full.
